The pattern must follow the TKGA Design Competition Design Format (found at www.TKGA.com) and must be in Word format (no exceptions).

6. Do NOT send the knit-up entry at this time:

Pre-judging will be completed **by May 17**. If you are chosen as a finalist, TKGA will notify you when and where to send your knit-up entry. (Non-finalists will be notified.)

7. Signature Required: I attest that the named design is my original unpublished design. By my submission to TKGA's Pattern Design Competition I do hereby release the design pattern to Yarnmarket for first right of refusal for publication whether or not I am a finalist, and if I am a winner I release the pattern to become the property of Yarnmarket. I agree to allow Yarnmarket to photograph my entry for publication, and Yarnmarket and TKGA may photograph my entry and myself for use in contest publicity. If I send my knit-up entry for judging, I hereby release Yarnmarket, TKGA and Offinger Management Company and their respective officers, agents and employees from any and all liability for loss or damage to my entry. I note that it has been recommended that I insure my knit-up entry against such loss and damage as could occur in connection with the competition.
